

If you mail your ballot, please include the proxy and ensure it is signed and dated. Only the Owner of record or the proxy holder may cast a vote, and only one vote per household is accepted. The deadline for voting is Wednesday, March 27th, 2024, 5:00 p.m. Please be sure your ballot reaches us before then.
